→ Will be required to complete a Work Book & Competency Book (provided) and these must be completed and returned to Joanna Green for marking within 3 months from the date of training. Certificates will be issued upon successful completion of the Workbooks (pass mark is 80%).

Ear Irrigation is an extended role for the HCSW and is a delegated task, therefore to enable safe practice:-

The patient has to be assessed by a GP/PN prior to delegating this task and documented there are no contraindications to irrigation.

The patient has to have had ear irrigation performed before without complications and must be over the aged of 16

These parameters have been advised by the RCN and MDU and continue after successful completion of the course, not just during training. Practice insurers will require notification of this extended role.
